Re: Notice of SCAG Regional Council Election

Date: February 16, 2024

OCCOG will be holding an election to fill the vacancy for the Southern California Association of Governments (SCAG) District 20 Regional Council/ OCCOG Board Member. As required by SCAG's Regional Council Policy Manual, this correspondence serves as notice of an upcoming election, which will be held on April 5, at 10:00 a.m., location TBD.

Nominations are now open for the OCCOG Board of Directors/SCAG District 20 Representative serving Los Alamitos, Seal Beach, Stanton, and Westminster. The SCAG Regional Council representative and OCCOG Board Member should be able to attend monthly meetings of the governing bodies: first Thursday of the month from 9:30-11:30 and 12-2 at SCAG's office in Los Angeles or another publicly accessible and properly noticed location. Fourth Thursday of the month 10:30-12;30 at the Los Olivos Community Center in Irvine or another publicly accessible and properly noticed location.

## General Information regarding the election, process, and eligibility are as follows:

Candidates: All elected officials from SCAG member cities within District 20 are

eligible candidates. A map of the Orange County SCAG District is attached for your reference. This call-for-candidates and election is being conducted to fill the vacancy of the District 20 seat that was previously held by Councilmember Joe Kalmick of Seal Beach. The District 20 Representative shall serve for the remainder of the two-year

term, which expires April 2026.

Elections: The election notice is a two-step process. This transmittal (first notice)

calls for candidates to declare interest within one month from the notice

date. As such, any interested candidates must notify the Executive

Director of the OCCOG of such interest via email at marnie@occog.com by March 20, 2024. A second notice will include candidate names and repeat

the election date, time, and participation details.

Election Procedure: District representatives shall be elected by a majority of a quorum. A

quorum is defined as at least one (1) elected official from 2/3 of the cities within a District. Elected officials must vote in person and proxy votes are

not permitted.

If there is only one (1) candidate, that individual shall be declared the SCAG

District Representative without having to conduct an election.

## General Information regarding stipends, etc.:

- \$120 stipend for SCAG-sponsored meetings (up to 6 meetings per month; 8 meetings for Officers). SCAG President may authorize two additional stipends.
- Public Transit reimbursement or mileage reimbursement (based on travel distance between member's seat of government and SCAG Los Angeles office).
- 3. Parking is validated at SCAG downtown Los Angeles office.
- 4. Lodging reimbursement not to exceed \$150 + taxes with travel requirement 75 miles or more (one-way) to attend SCAG meeting at SCAG Office in Los Angeles must make own travel arrangements and submit receipts. The SCAG President is authorized to approve higher lodging costs if government rate not available and reservation is made two weeks in advance.
- 5. For attending meetings on behalf of SCAG at locations other than SCAG Headquarters, RC members are eligible to receive the minimum stipend (\$120) and mileage reimbursement for actual miles traveled and actual parking expenses. RC members must complete an expense reimbursement form, a signed meeting attendance form and parking receipt.

6. OCCOG Board members are eligible to receive a stipend for attending monthly meetings of the Board of Directors in the amount of \$100 per meeting. Members may opt out of receiving the stipend if they prefer.
