

Concur with SCAG's Revisions to the Form Participant Agreements for Orange County Data Acquisition Partnership (OCDAP)

## **SUMMARY**

Request OCCOG Board concur with SCAG's revisions to the form Participation Agreements with interested agencies approved by the OCCOG Board in May 2020.

## **BACKGROUND**

Orange County agencies are partnering with SCAG to pool resources to purchase online and GIS-accessible aerial imagery for Orange County. This is tiered off of LA County's collaborative GIS effort known as LARIAC (Los Angeles Region Imagery Acquisition Consortium). https://egis3.lacounty.gov/dataportal/lariac/

At its May 28, 2020 meeting, the OCCOG Board approved the form Participation Agreement and authorized the OCCOG Executive Director to execute each separate Participation Agreement between OCCOG, SCAG and interested Orange County agencies.

By way of background, this joint effort will reduce the cost of purchasing aerial imagery and other GIS information that can be used by all departments within an agency without the need for GIS software by including a user-friendly, non-GIS platform; GIS users would have access to GIS data. Cycle 1 will include 3-inch pixel aerial/ortho imagery, infrared, and building footprints. The services will include in-person training, webinars, and additional support. Imagery and reference information is planned for early summer 2020, which would provide a critical baseline reference for the 2020 U.S. Decennial Census, CDR's 2022 Orange County Projections (OCP) and the 2024 RTP/SCS. Some of the goals are to reduce or eliminate duplicate purchases across the region, reduce costs using economies of scale, and allow for unlimited and cross-departmental users within an agency. Some sample uses are:

- Reference/point-in-time snapshots
- Measuring height of buildings, distance between manhole openings, curb-to-curb
- Counting number of floors in a building
- Sidewalk analyses
- Tree canopy coverage
- Vegetation coverage

The total project cost for Cycle 1 is \$383,603. SCAG has selected Eagle Aerial/Pictometry as the vendor and will handle the contract procurement. Currently, 16 agencies have indicated

participation and full funding has been reached to proceed with the project. Project details, data, and fees have been discussed and worked out via a small working group of participating Orange County agencies, which include water agencies, cities, and other special districts. For the FY2019/20 budget, the OCCOG Board approved a budget that included a contribution of \$20,000 to assist in lowering the cost for participating Orange County agencies; this is being carried over into FY2020-21. Several agencies are still considering joining and those interested in participation should contact Javier Aguilar, SCAG: (213) 236-1845 aguilar@scag.ca.gov.

At its February 2020 meeting, the OCCOG Board authorized OCCOG to take the lead in invoicing the participating agencies in Cycle 1 for the OCDAP. OCCOG will collect the funds and send them to SCAG. A Participation Agreement (PA) will need to be signed by each agency participating in Cycle 1 of OCDAP; the PA will also be signed by OCCOG, which will be invoicing and collecting the funds, and SCAG who is handling the procurement of the vendor contract. Copies of the PA will be prepared and distributed by SCAG for signature; this is expected to occur in late June or early July 2020. Each participating agency will also be required to sign a non-disclosure agreement, attached as an exhibit to the PA, requiring it and its employees, consultants and subcontractors to use the imagery solely on projects that are outsourced from its own operations.

SCAG has received sufficient notices of interest from participating agencies and is taking the contract with Pictometry to its Executive and Administration Committee (EAC) on Monday, June 22, 2020 for approval.

#### **DISCUSSION**

At its May 28, 2020 meeting, the OCCOG Board authorized the OCCOG Executive Director to sign separate Participation Agreements with interested agencies in the same form as attached to the May 28 staff report, as may be received from Orange County agencies for OCDAP Cycle 1. Since the May 28 meeting, SCAG staff reached out to the OCDAP working group and informed them that there were additional items and clarifications it required to include in the Participation Agreement after further review by multiple departments within SCAG. Though the working group was told by SCAG staff in mid-May that the PA was finalized, which is why it was brought to the Board on May 28, the working group met again on June 17 to go over SCAG's additional changes. The additional changes are attached in redline format. The most significant substantive change pertains to the dispersal of any surplus funds if the program does not continue past Cycle 1. SCAG wanted to ensure that any excess funds collected by OCCOG that are returned to the local agencies also include SCAG on a proportional basis since SCAG is contributing significant funding. The other changes confirm that any agency that drops out in subsequent cycles forfeits any excess funds that would be available following Cycle 1. Finally, OCCOG's General Counsel clarified the indemnification provision.

The OCDAP working group generally concurred that SCAG's proposed revisions are reasonable in light of the strong expectation that Cycle 2 will also move forward and communicated their understanding that their separate agencies would approve the revised PA. OCCOG Legal Counsel provided further clarifications to SCAG's proposed changes and finds the draft provided with this report acceptable.

# ORANGE COUNTY DATA ACQUISITION PARTNERSHIP (OCDAP) Participation Agreement between the Southern California Association of Governments, Orange County Council of Governments and [local agency name]

THIS ORANGE COUNTY DATA ACQUISITION PARTNERSHIP (OCDAP) PARTICIPATION AGREEMENT ("Agreement") is made and entered into this XX day of XX 2020, by and between [local agency name], hereinafter referred to as "[Local Agency]", Orange County Council of Governments, hereinafter referred to as "OCCOG" and the Southern California Association of Governments, hereinafter referred to as "SCAG" (hereinafter collectively also the "Parties").

## **RECITALS**

WHEREAS, the County of Los Angeles established a Los Angeles Region Imagery Acquisition Consortium (LARIAC) to lead the acquisition of purchasing Digital Aerial Data, in partnership with cities and agencies to reduce costs and enable participants to acquire more data than would be possible individually;

WHEREAS, the County of Los Angeles entered into an agreement with Pictometry International Corp. ("Pictometry") dated December 2013, including duly-approved amendments and/or addenda thereto, (collectively, the "LAC Agreement") after a competitive process, and each Party signing this Agreement acknowledges it has been provided a copy of such LAC Agreement, a true and correct copy of which is available at <a href="https://scag-nt/market/background

WHEREAS, the LAC Agreement provides that an External Entity (i.e., City, County, Joint Powers Authority or any governmental entity) may license or otherwise acquire rights to Digital Aerial Data outside of Los Angeles County pursuant to the pricing and other terms of the LAC Agreement;

WHEREAS, SCAG meets the criteria necessary to be an External Entity and SCAG therefore qualifies for the same pricing as the LAC Agreement, and, pursuant to its rights as an External Entity, SCAG is authorized to enter into this Agreement with OCCOG and the Local Agency;

WHEREAS, SCAG and Orange County agencies wish to enter into an agreement to obtain Digital Aerial Data to leverage the same pricing as the LAC Agreement. The group of participating agencies is known as the Orange County Data Acquisition Partnership ("OCDAP");

WHEREAS, SCAG entered or will enter into an Agreement with Pictometry for Digital Aerial Data ("SCAG Agreement") for the Orange County Data Acquisition Partnership Project ("Project"), which is substantially in the form attached to this Agreement as Attachment A. The Project includes one (1) cycle of data capture anticipated to begin in June 2020 for the period of July 2020 – June 2022 ("Cycle 1");

WHEREAS, the Parties intend for any funds contributed under this Agreement in excess of the SCAG Agreement cost to be allocated toward a cycle two (2) of data capture anticipated for the period of July 2022-June 2024 ("Cycle 2"), and to execute an amendment to this Agreement or new participation agreement for Cycle 2;

WHEREAS, the Parties recognize the need to invest in Digital Aerial Data to conduct local and regional planning and to evaluate current and future legislative and regulatory proposals and wish to utilize the Digital Aerial Data from the SCAG Agreement;

WHEREAS, OCCOG is responsible for invoicing the Parties for the Project in Cycle 1;

WHEREAS, the Parties wish to enter into this Agreement to outline the roles and responsibilities for the Project: and

WHEREAS the "Recitals" are incorporated herein by this reference:

## **TERMS OF AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Parties hereby agree as follows:

## 1. Compensation

The Local Agency will compensate SCAG as described in Section 4 for the Digital Aerial Data, described in Section 2 for the data capture in 2020 for Cycle 1. The total cost of Cycle 1 is \$383,603.10. The next geospatial data capture is expected in 2022 ("Cycle 2"). Agencies participating in Cycle 1 are not obligated to participate in Cycle 2. Regardless of whether the Local Agency chooses to participate beyond Cycle 1, the Local Agency is authorized to possess and use the Cycle 1 Digital Aerial Data described in Section 2 for its organizational purposes in perpetuity, subject to the use provisions set forth in Section 3 and disclosure provisions of Section 5. If applicable, an amendment to this Agreement or separate participation agreement will be executed by the Parties for Cycle 2 and the distribution of funds for Cycle 2 will be addressed separately by such amendment or separate participation agreement. In such event, funds received in excess of the Cycle 1 costs shall be applied to Cycle 2. In the event that the Local Agency determines not to participate in Cycle 2, funds paid in excess of the Cycle 1 costs, shall be forfeited. If the OCDAP does not continue past Cycle 1, any funds collected by OCCOG in excess of the Cycle 1 costs shall be returned to the Local Agencies and SCAG in proportion to their separate contributions.

## 2. <u>Digital Aerial Data Description</u>

- A. Digital Imagery: 3-inch resolution, 4 band (red, green, blue, and near infrared) true natural color digital orthophoto/ortho-rectified data covering Orange County as shown in the map in Attachment B, attached hereto and incorporated herein by this reference. Digital imagery will be provided in the following formats: GeoTIFF tiles and mosaic of ECW or Mr.SID tile format (which includes seamline generation, radiometric balancing and final color balancing to ensure seamless consistent coverage of the area of interest). These data will be California State Plane Coordinate System, Zone 6 (US feet), Datum NAD 83.
- B. Building footprints: Outlines of building footprints for structures that are 300 square feet or greater will be provided for all Orange County in shapefile format with z values. These data will be California State Plane Coordinate System, Zone 6 (US feet), Datum NAD 83. The vertical datum will be North American Vertical Datum of 1988 (NAVD88), US Feet.
- C. Pursuant to the terms of the LAC Agreement, which is fully incorporated herein by reference, the Parties will have access and use of all imagery collected and processed through the online viewing software hosted by Pictometry through the LAC Agreement or be provided copies of the data by SCAG as described in Section 3.

## 3. <u>Data Delivery</u>

When possible, the digital data will be provided electronically through the online platform hosted by Pictometry or through File Transfer Protocol (FTP) by SCAG. Alternatively, upon request and receipt of a hard drive from the Local Agency, the digital imagery data will be provided by SCAG on such hard drive within 30 days of receipt by SCAG, subject to any use restrictions set forth in the agreement between SCAG and Pictometry or the LAC Agreement.

## 4. Invoicing/Payment

OCCOG, on behalf of SCAG, will submit an invoice to the Local Agency for XXX as payment for Cycle 1 Digital Aerial Data. The Local Agency will submit payment to OCCOG within 30 days. This will be a line item invoice for those agencies that also receive an annual invoice for OCCOG dues (for OCCOG member agencies) and CDR fees. OCCOG shall invoice the Parties in July 2020. OCCOG will remit collected payments to SCAG within three months of invoicing Parties. In the event payment is not received by OCCOG from the Local Agency, the Local Agency will be denied access to the online data platform and will not receive copies of the data from SCAG.

The parties further understand and acknowledge that if SCAG does not proceed to approve the SCAG Agreement, this Agreement shall be deemed null and void and the parties will have no further obligations.

### 5. Disclosure of Information

<u>The Local Agency</u> may distribute the Digital Aerial Data to its subcontractors or consultants on projects that are outsourced from its own operations. The Local Agency shall require each subcontractor or consultant to whom the Digital Aerial Data is transferred or distributed to execute a written acknowledgement and agreement provided as Attachment C, Orange County Data Acquisition Partnership (OCDAP) Authorized User Confidentiality and Non-Disclosure Agreement, attached hereto and incorporated herein by this reference.

### 6. Representations and Warranties

SCAG warrants that the Digital Aerial Data does not and shall not violate: (a) any applicable law, rule, or regulation ("Laws"); or (b) any contracts with third parties; or (c) any third-party rights in any patent, trademark, copyright, trade secret, or any other proprietary or intellectual property right.

SCAG represents that it will identify, obtain and keep current all necessary licenses, approvals, permits and authorizations as may be required from time to time under applicable Laws and third-party contracts with respect to the Digital Aerial Data.

SCAG warrants that it has full authority and sufficient right, title, and interest in and to the Digital Aerial Data subject to the terms set forth in the LAC Agreement to grant and convey the rights accorded to the Local Agency under Section 32.

<u>The</u> Local Agency warrants that its use, grant, and conveyance of the Digital Aerial Data will not violate any applicable terms set forth in the LAC Agreement.

## 7. Indemnification

SCAG agrees to indemnify and defend the Local Agency and OCCOG against all third-party claims, liabilities, losses, expenses, suits, actions and causes of actions (including reasonable attorneys' fees and legal expenses), fines, penalties, or damages (collectively, the "Liabilities") to the extent such Liabilities

arise out of or result from: (a) the negligent acts or omissions, the willful or intentional misconduct of SCAG or its employees, subcontractors or agents, in the course of providing the Digital Aerial Data; (b) SCAG's breach of the terms of this Agreement; or (c) any claim that any of Digital Aerial Data provided by SCAG infringes or misappropriates a third party's intellectual property rights.

<u>The Local Agency agrees to indemnify and defend SCAG and OCCOG</u>, <u>its-their directors</u>, officers and employees, against all Liabilities to the extent such Liabilities arise out of or result, from: (a) the negligent acts or omissions, the willful or intentional misconduct of Local Agency or its employees, subcontractors or agents under this Agreement; or (b) Local Agency's breach of the terms of this Agreement.

## 8. Amendments

No alteration or deviation of the terms of this Agreement shall be valid unless made in writing and properly executed by the Parties.

Any notice or notices required or permitted to be given pursuant to this Agreement may be personally served on the other party by the party giving such notice, or may be served by certified mail, return receipt requested, to the following addresses:



- Recognizing agencies may currently be in multi-year contracts, this information can be used for future budgeting and procurement.
- Cycles run for two fiscal years:
  - o Cycle 1: July 2020-June 2022
  - o Cycle 2: July 2022-June 2024
  - o Cycle 3: July 2024-June 2026
  - o Cycle 4: July 2026-June 2028
  - o Cycle 5: July 2028-June 2030
- Aerials will be flown every two years
- LiDAR- about every 5-6 years (TBD)

# Approval of FY 2020-2021 OCCOG Budget

## **SUMMARY**

The draft 2020-21 Budget is presented for Board review and feedback. The following are key points about the budget.

Programs and Work Plan items included in the FY 2020-21 Budget

- General Assembly will be held in Spring 2021
- New Orange County Data Acquisition Partnership
- Consultant services retained for financial bookkeeping, counsel, clerk of the board, executive director, legislative tracking and analysis, grant-writing, marketing/communications, general assembly support, video development, and administrative support

#### Revenues:

- Data Acquisition Collection, net of \$56,672 held in reserve by OCCOG
- Dues level will remain the same as June 2019/20 Budget
- CDR fees slightly by \$6,000 in total per previously approved MOU.

A mid-year budget adjustment will be required for the Board-approved REAP program to be submitted to SCAG this fall.

The draft FY 2020-21 Budget anticipates total revenues of \$607,506 and expenditures of \$605,970, for a net increase in fund balance of \$1,536 for the year. With an opening fund balance estimated at \$362,141, the ending fund balance at June 30, 2021 is projected to be \$363,677. Per the Board-approved reserve policy the funds held in reserve for emergency purposes are \$236,184.

# STAFF RECOMMENDATION

Approve the OCCOG FY 2020-21 Budget as presented or amended.

# Approve 2020-2021 OCCOG Work Plan

## **SUMMARY**

The OCCOG has chosen to operate using contract staff to conduct its business in a cost-effective and efficient manner. The 2020-2021 draft Work Plan reflects the resources available to the OCCOG for the 2020-2021 fiscal year and the priorities the Board has expressed. The FY 20-21 Work Plan includes several major initiatives and ongoing projects:

- 2021 General Assembly
- Orange County Aerial Imagery Project (OCDAP)
- REAP Grant Program Development and Management
- Legislative and Grant Writing Support
- Marketing and Communications

The team of consultant resources will be managed by the Executive Director and will work cooperatively to achieve the goals and support the mission of the OCCOG. The Work Plan is intended to support OCCOG's member jurisdiction activities, including providing support for grant writing, legislative tracking and analysis, facilitating discussion and continued education on important policy areas including water, energy, land use and housing, transportation, and air quality, and delivering educational tools to support public engagement on policy issues important to members.

In addition, this fiscal year includes the launch of Orange County's aerial imagery data consortium. The Orange County Data Acquisition Partnership (OCDAP) has been spearheaded by CDR's Director, Deborah Diep and is largely funded by the Southern California Association of Government (SCAG) with contributions from over a dozen Orange County partner agencies. OCCOG will be acting as the pass-through billing agency for the consortium. We hope that additional partners will be joining the consortium as we move forward, as the data provided is very useful to multiple jurisdictions and functional units within agencies.

FY 20/21 will also see a one-time infusion of funding provided by SCAG for the Regional Early Action Planning (REAP) Grant. Funds from this grant can be used to support planning activities around increasing the housing supply. OCCOG staff has been working with the Executive Management Committee (EMC) and the Technical Advisory Committee (TAC), as well as the Orange County City Managers Association (OCCMA), to develop a plan that will benefit all OCCOG members for using the available REAP funding to present to the OCCOG Board and SCAG for approval in early fall 2020.

## Letter of Agreement

Upon acceptance of the terms and conditions set forth below, this document shall serve as a Memorandum of Agreement ("Agreement") between Barrios & Associates, LLC., DBA Communications LAB (the "Firm") and Orange County Council of Governments (the "Client").

- 1. The Client has retained the Firm to assist the Client on various projects to be determined by the Client. The Firm shall provide services as noted in the attached Scope of Work.

- 6. The Firm has designated Arianna Barrios, CEO as the key contact with the Client. Any change in this key contact by the Firm will be communicated in writing to the Client.
- 7. Either party has the right to terminate this Agreement upon 30 days written notice to the other party with or without cause. Any amounts, which remain due and owing up to the date of termination, shall be paid within 15 days of said termination.
- 8. All final information, artwork and data resulting from this Agreement shall be the sole property of the Client, and the Client shall have the right to use such materials for any purpose whatsoever. The Firm may retain for its own internal use, copies of such materials.
- 9. Unless the Client otherwise consents, the Firm shall not disclose to or use for the benefit of third parties, (1) information disclosed by the Client to the Firm, pursuant to this Agreement, which the Client has advised the Firm shall be considered confidential information, and (2) fact sheets, other Client specific information, or similar type of materials developed by the Firm pursuant to this Agreement which the Client has advised the Firm shall be considered confidential.

- 10. Any dispute arising under this Agreement shall be submitted to binding arbitration in Orange County, in accordance with the commercial arbitration rules of the American Arbitration Association. The costs and attorney's fees of the prevailing party in any such arbitration shall be borne by the other party and shall be set by the arbitration. Said finding shall be binding on both parties.
- 11. The Client shall indemnify Firm and hold the Firm harmless from and against any and all claims that may at any time be made against the Firm as a result of statements made or materials produced by the Firm provided that such statements and materials are pre-approved by the Client, except to the extent that such claims result from the negligence of the Firm. The Firm shall submit all proposed statements or materials to the Client for approval prior to the publication of such statements and materials.
- 12. The Firm shall indemnify and hold the Client harmless from and against any and all claims that may at any time be made against the Client as a result of statements made or materials distributed by the Firm without the approval of the Client.

The current contract between OCCOG and Eileen White for clerk of the board services ends June 30, 2020. A contract amendment is required to extend her services. Additionally, OCCOG staff and Ms. White have agreed to adjust the form of the contract from an hourly rate of \$55/hour to a retainer-based contract. In FY 19-20, OCCOG brought Kathryn Morrison on board to assist in administrative tasks that were extraneous to the scope of services for Clerk of the Board. Staff anticipated that the change would result in a reduced cost for Clerk of the Board services, however the level of effort was greater than either the Clerk or the Executive Director anticipated. To better manage costs, the clerk has suggested a retainer arrangement and the OCCOG and Ms. White have agreed to a retainer of \$1500 per month for clerk of the board related services. This will help keep costs in line with the budget, while still compensating Ms. White fairly for her excellent work. The annual contract amount will not exceed the approved OCCOG Budget.

### STAFF RECOMMENDATION

Approve Amendment No. 4, changing the form of the contract from an hourly rate to a retainer amount of \$1500 per month. The annual contract amount will not exceed the amount budgeted in the OCCOG approved FY 2020-21 budget.

# Resolution Regarding SB 743 VMT Analysis Delay Request

### **SUMMARY**

For the past seven years, local jurisdictions have been working with the Governor's Office of Planning and Research (OPR), California Natural Resources Agency (CNRA), California Department of Transportation (Caltrans), Southern California Association of Governments (SCAG), and stakeholders to transition to Vehicle Miles Traveled (VMT) analysis as required by SB 743.

SB 743 mandates that this transition be finalized by June 30, 2020 with VMT going into effect July 1, 2020. As part of the legislative update agenda item at the May 28, 2020 OCCOG Board of Directors meeting, the Board discussed the request by ex-officio member Steve LaMotte of the Orange County Chapter of the Building Industry Association (BIAOC) to consider sending a letter or passing a resolution requesting the Governor to delay the implementation of SB 743 VMT analysis until July 1, 2022. The Board had previously taken an opposed position to SB 743 and had been monitoring the process of developing the VMT guidelines over the seven-year period. This position consistent with the OCCOG legislative guidelines allowed the Board to direct Executive Director Primmer to write a letter, which was done on June 10, 2020 (see Attachment A), The Board further directed that the item be brought back for Board action at the next meeting, June 25, 2020.

### **BACKGROUND**

On September 27, 2013, Senate Bill 743 (SB 743) was signed by then-Governor Brown. The new law precluded the use of "Level of Service" (LOS), a metric of automobile delay, from being used in California Environmental Quality Act (CEQA) analysis in favor of a new metric, Vehicle Miles Traveled (VMT), as a determinant of environmental impacts for transportation. Subsequently, in December of 2018, after five years of public consultation the California Natural Resources Agency (CNRA) certified and adopted the CEQA Guidelines update package, which included the Guidelines section implementing Senate Bill 743. In addition, the State of California Office of Planning and Research (OPR) developed a Technical Advisory on Evaluating Transportation Impacts in CEQA, which contains OPR's technical recommendations regarding assessment of (VMT), thresholds of significance, and mitigation measures.

CEQA is California's environmental law that sets standards and practices for reviewing a project's impact on the environment. CEQA requires jurisdictions to review and disclose the impact a project would have on the environment to the public and decision makers and as a result reduce those impacts. CEQA establishes four categories of environmental impacts:

- 1. No impact
- 2. Less than significant impact
- 3. Less than significant impact with the adoption of mitigation measures
- 4. Significant unavoidable impacts

A "threshold of significance" is the point at which an impact moves from less than significant to significant. CEQA defines a significant impact as "a substantial, or potentially substantial, adverse change in the environment." Agencies adopt defined thresholds of significance for each of the 18 areas studied under CEQA.

With the passage of SB 743, California mandated that local jurisdictions move away from LOS, the traditional method of quantifying the environmental impact from projects on the transportation network, which measures the creation of congestion. In lieu of LOS, SB 743 requires that VMT be considered for CEQA purposes. VMT measures the volume and distance vehicles travel as a result of project development. VMT is the number of miles all vehicles travel, and it is the State's goal to reduce VMT and thereby reduce greenhouse gas emissions and the adverse impacts associated with climate change.

While SB 743 changes the focus of traffic analysis to reducing VMT, it also does not prohibit jurisdictions from setting LOS standards for infrastructure planning purposes. In fact, many jurisdictions are opting to keep their level of service analysis to ensure General Plan or Specific Plan consistency for projects, as well as implementing VMT analysis for projects under CEQA. The added cost for undertaking both analyses has been a main point of contention for OCCOG and many of our jurisdictions.

SB 743 reorients CEQA away from the negative impacts of traffic congestion and toward potential negative environmental effects of automobile travel (air pollution and greenhouse gas emissions). Despite being required to adopt VMT thresholds there may be some areas in which jurisdictions have some discretion. Jurisdictions can use this discretion to determine whether they risk potential litigation and/or whether they can reduce the expensive and onerous CEQA process on projects that comply with their General Plan. Examples of some areas where jurisdictions may have some discretion include:

Local-Serving Projects – The State allows cities to filter or "screen out" local serving
projects so that they do not even require a traffic study for CEQA purposes. The idea
behind this is that since they serve the local population, they are likely reducing the need
for people to drive further away and thus are reducing VMT. Jurisdictions could consider
adopting a list of local serving project types that are consistent with the state's Office of
Planning and Research's (OPR) guidance.

- Projects in Low VMT Areas The State allows jurisdictions to filter out regions of their sphere of influence that are already considered "low VMT" traffic analysis zones (TAZs).
   Low VMT zones are identified through the use of sophisticated travel demand models. The rationale is that the area likely already has a good mix of uses and adding additional uses in this area provides for less and/or shorter trips and bundling of trips.
- Projects in Transit Priority Areas (TPA) OPR guidance allows jurisdictions to screen out projects in TPAs, which are defined as locations within a half-mile of a transit stop or station with a minimum of 15-minute headways during peak commute hours.
- Affordable Housing Projects OPR guidance allows jurisdictions to screen out affordable housing developments or affordable housing units within mixed-use developments.

VMT continues to be an imperfect metric for quantifying environmental impacts of transportation. Mitigation measures for VMT impacts associated with specific land development projects is difficult if not impossible. Most land development projects will therefore require the preparation of costly EIRs, and risk significant time delays and approval uncertainty as Statements of Overriding Considerations are prepared. We have made strides in increasing market share of electric, hybrid, and alternative fuel vehicles, which have lower GHG and particulate matter emissions. California funds our transportation network via a gas tax, which acts as a proxy for VMT. If we actively seek to reduce VMT, without replacing the funds needed to maintain and expand our transportation network, air quality will continue to suffer and congestion will only worsen.

Proximity to the July 1, 2020 deadline means most jurisdictions have begun to make the transition to VMT. However, with the impacts of COVID-19 quarantine orders on local jurisdictions and significant budget impacts, a request for a delay of at least 6 months, and up to the BIA-requested delay of 2 years will ensure that the VMT implementation goes smoothly, to avoid costly delays.

### STAFF RECOMMENDATION

Approve the Board-requested Resolution No. 20-02 as presented or amended.

Subject: Extension of July 1 VMT Implementation

### Dear Governor Newsom:

On behalf of the Orange County Governments (OCCOG), I would like to thank you for your leadership and prompt and decisive action to protect our state from the COVID-19 pandemic. By taking this threat seriously and taking the necessary actions to prevent its rapid spread, you have likely reduced the impacts on our healthcare system, economy, and housing that are sure to come. It is in this spirit that I bring to your attention a regulation that will dramatically impact the ability for many Californians, including young families, essential workers, and communities of color, to purchase a home - Vehicle Miles Travelled (VMT), and respectfully request the extension of the implementation date of the integration of VMT analyses in CEQA, to July 1st, 2022.

Pursuant to SB 743, in December 2018, the California Natural Resources Agency adopted new regulations for the implementation of the California Environmental Quality Act (CEQA). The new CEQA Guidelines contain many provisions that will increase the likelihood that housing projects will be subject to litigation and cost increases. Among them was the newly-proposed impact known as VMT which would replace the previous analysis of traffic impacts called Level of Service (LOS).

Whereas LOS analysis examines the delay created by a new project, and therefore the impact to the overall mobility system, the CEQA implementation of SB 743 will now require VMT to be the new metric for transportation impacts under CEQA. This new analysis requires local governments to analyze the vehicular trips generated by future development projects. This will require housing projects to quantify how many miles home buyers, renters, and tenants will drive to work, to the store, for recreation, and other purposes. The VMT analysis will also require commercial and industrial projects to quantify the miles generated by the employees and services related to such uses.

The ideological approach of VMT is to get people to abandon their individual vehicles and use alternative mobility options such as walking, biking, carpooling, and public transit. The regulation views road congestion as a good thing, since it slows down traffic and incentivizes individuals to use alternative forms of transit. Improvements like road widening are considered a negative impact on greenhouse gas reductions because it increases commuter speeds which the regulation assumes will encourage people to

drive longer distances. The new regulation advocates that California go on a "road diet" and calls into question whether the voters understood this when they approved an increase in the gas tax.

In addition to existing laws, which require the quantification and mitigation of air quality impacts, including greenhouse gas emissions, from tail pipes, VMT introduces a new impact, and added costs, to the environmental review process. Disturbingly, it will apply even once we convert to 100% zero emission vehicles. And, not coincidentally, since we fund transportation improvements, including transit service and active transportation infrastructure as well as highways and local streets and roads, from the state gas tax, as we see VMT drop and more alternative fuel vehicle on our roads, funds that support our transportation network will drop as well.

VMT regulation disproportionately impacts communities of color, and those farther away from job centers, which are often the most affordable areas. Not surprisingly then, these locations provide much needed housing for low- and middle-class Californians. Measures to mitigate VMT, especially in rural areas, significantly drive up the costs of residential development.

Our partners in the development community are sounding the alarm that VMT regulation will increase, not decrease, the cost of housing. They have identified that every \$1,000 increase in the cost of a home eliminates 8,870 households from the ability to afford a home, putting the American dream of homeownership - the primary method of establishing economic stability, community participation and economic growth - further out of reach for those struggling to afford a home today. OCCOG is concerned that this will have its greatest impacts on classes protected by the federal and state constitutions and a variety of federal and state laws prohibiting housing discrimination.

While our member jurisdictions are taking steps to ready themselves to make the transition from LOS to VMT analysis, I would be remiss if I did not point out to you how big of a disconnect there is between the aspirations of SB743 and the implications of the implementation of the VMT impact on the housing crisis and our ability to pay for critical transportation infrastructure improvements. Further, there is still a critical missing piece in the implementation puzzle: a more comprehensive approach on how to effectively implement VMT mitigation. Researchers are concluding that on-site mitigation alone cannot effectively reduce project-level VMT to local government-adopted targets. Thus, the time extension requested, would allow our regional and county transportation partners to not just study, but implement regional and areawide approaches for VMT mitigation that can be achieved collaboratively and with support of our development community partners. OCCOG is ready to assist in this effort.

There are also special impacts from the COVID-19 health crisis, which has already produced dramatic reductions in VMT, that should result in further refinement of how VMT is implemented to ensure equity and a steady funding source for transportation investments across our state. Therefore, we respectfully request that you extend the implementation of the VMT regulation for two years, to July 1, 2022. Thank

### **AGENDA ITEM #15**

### **LEGISLATIVE UPDATE**

### **SUMMARY**

This legislative update provides updates on federal appropriations and surface transportation activities, as well as state bills of interest to OCCOG, upcoming legislative deadlines, and the state budget.

### **BACKGROUND**

The Legislative Update is provided to keep the OCCOG Board apprised of legislative and regulatory actions that address land use and housing, energy, mobility, air quality and water issues.

### **DISCUSSION**

### **FEDERAL UPDATE**

### **Federal Appropriations Update**

The House is scheduled to begin marking up appropriations bills for Federal Fiscal Year (FFY) 2021 during the weeks of July 6<sup>th</sup> and 13<sup>th</sup>, with floor votes targeted for the weeks of July 20<sup>th</sup> and 27<sup>th</sup>. On the Senate side, the Senate Appropriations Committee is scheduled to begin marking up FFY 2021 bills the week of June 22<sup>nd</sup> with the remainder being considered after the July 4<sup>th</sup> recess.

### Surface Transportation Reauthorization Update

The House released a surface transportation bill, HR 2, on June 4<sup>th</sup>, with some amendments released shortly there after that includes new provisions related to toll credits and restricting transit agencies from using federal funds to support mobility services like bike-sharing and ride-hailing apps. On June 17<sup>th</sup>, the House Transportation & Infrastructure Committee is scheduled to begin markup and consider hundreds of proposed amendments.

The Investing in a New Vision for the Environment and Surface Transportation in America (INVEST in America) is a five-year, \$494 billion proposal. Major elements include:



### • \$319 billion for Highways

- Prioritizes a "fix it first" approach to fixing the existing system before new capacity is built
- o Incentivizes greenhouse gas emission reductions and provides funding for resilient infrastructure that can withstand climate change
- Provides funding for charging stations and alternative fueling options for electric and zero emission vehicles
- Expands eligibility for safe routes to school
- Provides funding for active transportation projects
- Funds technology deployments that increase innovation and supports the creation of more efficient transportation systems.

### • \$105 billion for Transit

- Increases funding for new routes and to increase service reliability
- Creates a Mobility Innovation program to incentivize collaboration for mobility on demand services
- Strengthens Buy America provisions
- Increases investment in zero-emission buses
- Proposes to streamline the Capital Investment Grant program to deliver projects more quickly
- Addresses transit maintenance backlog needs

### • \$60 billion for Rail

- Allocates \$29 billion over five years to Amtrak
- Creates a \$19 billion Passenger Rail Improvement, Modernization and Expansion (PRIME) grant program to fund passenger rail improvements and expansion
- Includes \$7 billion for the Consolidated Rail Infrastructure and Safety Improvements (CRISI) program
- Establishes a new \$2.5 billion grade separation grant program
- \$10 billion for Passenger Vehicle and Motor Vehicle Safety Investments
  - Provides \$5.3 billion over five years for highway safety programs
  - o Allocates \$4.6 billion over five years for truck and bus safety programs

The Senate Environment and Public Works Committee has already approved the highway portion of its bill, S. 2302. It has not yet been taken up on the Senate floor. Neither house has yet determined how the reauthorizations would be paid for.

The Fixing America's Surface Transportation (FAST) Act is currently set to expire on September 30, 2020.

### State Budget Update

On June 15<sup>th</sup>, the Legislature approved SB 74 (Mitchell, D-Los Angeles), a "placeholder budget" in order to meet the constitutionally required deadline for passage of the budget. The Legislature is continuing to negotiate with the Governor to reach an agreement before July 1<sup>st</sup>. As of the writing of this report, the agreement had not yet been reached though agreement may come as early as June 19<sup>th</sup> when the Assembly breaks for summer recess. Remaining issues include anticipated revenue for the coming fiscal year, how much the state can expect in aid from the federal government, and emergency pandemic spending as well as funding for schools, county realignment funding, and Medi-Cal payments.

The placeholder budget adopted by the Legislature largely avoids the cuts proposed by Governor Newsom in the May Revise. Elements of the approved budget include:

- \$11.8 billion in reserves
  - o \$2.6 billion in regular reserves, including \$700 million for COVID-19
  - o \$900 million Safety Net Reserve
  - o \$8.35 billion in the Rainy Day Fund
- \$14 billion in federal aid
  - If federal aid is not received by October 1<sup>st</sup>:
    - Reserve accounts drop to \$1 billion in regular reserves and \$6.5 billion in the Rainy Day Fund
    - The following trigger cuts occur:
      - \$1.3 billion to reinstate a PERS payment deferral
      - \$5.3 billion in Proposition 98 deferrals, rather than cuts
      - \$600 million in county realignment funds
      - \$770 million for the UC and CSU systems
      - \$100 million to the Judiciary
      - A June Payroll deferral if January's updated budget forecast is worse than anticipated
- Maintains corporate tax changes proposed in the May Revise, raising an estimated \$4.4 billion in FY 2020-2021, as well as \$3.3 billion FY 2021-2022 and \$1.9 billion in FY 2022-2023.
- Other major differences with the May Revise in areas of interest include:
  - Provides \$50 million for AB 617 Community Air Grants to reduce air pollution in impacted communities
  - o Provides \$13 million for transitional housing and housing navigators for foster youth
  - o Provides \$350 million for local government homelessness programs
  - Provides an additional \$130 million for transportation projects
  - o Rejects a proposed transfer from the State Highway Account



- Rejection of proposals by the Governor to reduce affordable housing funding, provides nearly \$250 million for affordable housing development in FY 2020-2021
- o Rejection of proposals to cut \$8.1 billion from K-12 schools
- Recommends that the California Air Resources Board initiate rule making to improve the Cap and Trade Fund

### **GRANT UPDATE**

The California Air Resources Board (CARB) has announced funding through the Sustainable Transportation Equity Project (STEP) for planning and clean transportation projects through two grant programs, with up to \$22 million in funding available.

The planning and capacity building grant program has up to \$2 million available to help identify community transportation needs and prepare for the implementation of clean transportation projects. The implementation grant program has up to \$20 million available for one to three grants for clean transportation projects. Funded projects must increase residents' access to the transportation system without the use of a personal vehicle.

Applications are due to CARB by Monday, August 31, 2020 at 5:00 p.m.
